Report of the Registrar

Molly Goldsmith reported that there is legislation pending the Governor's signature.

- Curbside voting: will need to put signs out that indicate Curbside is available.
- Absentee voting availability on Sundays; this would be up to the discretion of the Electoral Board.
- Unlawful possession of firearms in polling places.
- June primary will be moved to the 3rd week.
- Municipality elections will be moved to November.
- Need to be aware that witness signatures are required until the Governor signs legislation. Additionally ballot boxes are not to be used, nor is ballot curing to happen, until the Governor signs.
- Prepaid postage—it has been advised to send envelopes with prepaid postage. Reimbursement is pending budget approval.
