REGISTER A FICTITIOUS NAME: You must register your fictitious name as a sole proprietor or partnership. You will need to register the name with the *State Corporation Commission* at (804) 371-9967, or online at www.scc.virginia.gov. A copy of the registration must be provided to our office before a business license can be issued.

REGISTER A CORPORATION: All corporations conducting business in the state of Virginia must be registered with the State Corporation Commission. For more information, contact the *State Corporation Commission* at (804) 371-9967, or online at www.scc.virginia.gov. A copy of the registration must be provided to our office before a business license can be issued.

DEPARTMENT OF PROFESSIONAL AND OCCUPATIONAL REGULATION: Any individual required to obtain professional credentials, must be licensed with DPOR. For more information, contact the *Department of Professional and Occupational Regulation* at (804) 367-8500, or online at www.dpor.virginia.gov. A copy of the current license must be provided to our office before a business license can be issued.

FEDERAL EMPLOYEE IDENTIFICATION NUMBER: A FEIN is a unique nine-digit number assigned by the Internal Revenue Service to a business for the purpose of identification and tax administration. For more information, contact the *IRS* at (800) 829-1040, or online at www.irs.gov. *No business license will be issued until all delinquent business license and personal property taxes owed by the applicant to the City of Staunton have been paid (VA Code 58.1-3700).*
