However, if award of Contract is delayed by the required approval of another government agency, the sale of bonds or the award of a grant or grants, Bids may not be withdrawn by the Bidder for a period not to exceed 120 days from the date of bid opening.

Staunton City Schools reserves the right in its sole discretion to reject any or all Bids and to waive irregularities in any Bid. Further, Staunton City Schools reserves the right to award any combination of Alternates, or no Alternates, which in its sole discretion, serves the best interests of the School Division.
