Electoral Board Canvass

Glenn Graves called the meeting to order at 10:01am.

Tom Long led the Pledge of Allegiance.

Tom Long made a motion to approve the minutes of the May 2020 Canvass. Glenn Graves seconded. The motion passed

The Electoral Board conducted the canvass and recorded the following:

Ward 1:

- Statements of Results were reviewed and there were no changes
- There were no provisional ballots.
- No Incident Report.

Ward 2:

- Statements of Results were reviewed and there were no changes.
- 1 voter checked in and returned the ballot deciding not to vote in the primary, however the voter was not unchecked in; therefore the record shows 246 voters, with 245 votes cast.
- There was 1 provisional ballot.
- No Incident Report

Ward 3:

- Statements of Results were reviewed and there were no changes.
- 2 voters checked in and returned the ballot deciding not to vote in the primary, however the voter was not unchecked in; therefore the record shows 181 voters, with 179 votes cast.
- There were 3 provisional ballots.
- No Incident Report

Ward 4:

- Statements of Results were reviewed and there were no changes.

- There were no provisional ballots.
- No Incident Report

Ward 5:

- Statements of Results were reviewed and there were no changes.
- There were 2 provisional ballots.
- No Incident Report

CAP:

Statement of results were reviewed. There were no changes.

Mr. Graves made a motion that the Board go into executive session for the purposes of discussing provisional ballots. Anne Fitzgerald seconded. Motion carried.

Mr. Graves made a motion to come out of closed session. Mr. Long seconded. Motion carried.

Certified that only business pertaining to the motion was discussed in closed session.

Graves: Aye

Long: Aye

Fitzgerald: Aye

Anne Fitzgerald made a motion that we count Ward 2: 1, Ward 3:1, Ward 5: 2, for a total of four ballots. Mr. Graves seconded. Motion carried.

The votes were as follows:

Gade: 3

Speciale: 0

Baldwin: 1

Two provisional ballots in Ward 3 were rejected because the voters had voted absentee, and their votes were counted in absentee.

There were a couple of wards that had ballots that were misprinted in that there was only a seal on one side, but no ballot on the other. We will call the vendor to discuss.

Ward 5 had a voting machine that was not working. Mr. Graves had to get a replacement. This occurred prior to, and just after, the polls were open. However, there were no voters who balloted at that time.

The next Electoral Board meeting is scheduled for Thursday, July 23rd, at 1pm.

Mr. Graves made a motion to adjourn at 11: 14am and Mr. Long seconded. Motion Carries.
